of water heretofore appropriated under Permit No. 27026

- 1. The source of water is Underground
2. The amount of water to be changed 4.6 cubic feet per second
3. The water to be used for irrigation and domestic
4. The water heretofore used for quasi-municipal
5. The water is to be diverted at the following point: In the NE 1/4 NW 1/4 Section 9, T-12-N, R-62-E, M.D.M. White Pine County, Nevada at a point from which the SW corner
6. The existing point of diversion is located within Same as 5
7. Proposed place of use E 1/2 E 1/2 Section 8; W 1/2 Section 9; NW 1/4, W 1/2 NE 1/4, NW 1/4 SE 1/4, and NE 1/4 SW 1/4 Section 16, T-12-N, R-62-E, M.D.M., White Pine County, Nevada, for 800 acres.
8. Existing place of use E 1/2 E 1/2 Section 8; W 1/2 Section 9; NW 1/4, E 1/2 NE 1/4, NW 1/4 SE 1/4, and NE 1/4 SW 1/4 Section 16, T-12-N, R-62-E, M.D.M., White Pine County, Nevada, for 800 acres.
9. Use will be from January 1 to December 31 of each year.
10. Use has been from January 1 to December 31 of each year.
11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Existing well with pump and motor, to be transported to lands by surface channels.

- 12. Estimated cost of works.....\$500.00
- 13. Estimated time required to construct works.....one year
- 14. Estimated time required to complete the application of water to beneficial use.....three years
- 15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This permit with permits concurrently applied for under applications to change manner of use from Permits 27025 through 27031 are for a combined annual duty of 3200 acre feet.

 APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the manner of use of the waters of an underground source as heretofore granted under Permit 27026 is issued subject to the terms and conditions imposed in said Permit 27026 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The total combined duty of water under this permit and Permits 30055, 30056 and 30058 through 30061 shall not exceed 3200 acre-feet per year. This permit is also subject to the terms and conditions set forth in the State Engineer's ruling of August 16, 1976.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not

to exceed 4.6 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Work must be prosecuted with reasonable diligence and be completed on or before..... November 9, 1976
- Proof of completion of work shall be filed before..... December 9, 1976

- Proof of the application of water to beneficial use shall be filed on or before..... December 9, 1977
- Map in support of proof of beneficial use shall be filed on or before..... December 9, 1977
