The applicant Maggie Creek Ranch, Inc. P. O. Box 1838, of Elko Nevada 89801

hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) November 10, 1975, Nevada

1. The source of the proposed appropriation is Underground Well No. 2

2. The amount of water applied for is 6.0 cfs second-foot

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Irrigation & Domestic

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 600 acres

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: NE 1/4 SW 1/4, Sec. 15, T33N, R52E, MDM, at a point from which the SW corner of said Section 15 bears S 43°00' W 2312 feet

6. Place of use. Portions of: Section 15; E 1/2 NE 1/4 Sec. 16, W 1/2 SW 1/4 Section 14, E 1/2 NE 1/4, NW 1/4 NE 1/4 Section 22, W 1/2 Section 23, all in T 33 N, R 52 E, MDM

7. Use will begin about January 1 and end about December 31 of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled and cased well, deep well turbine ditches and laterals for flood irrigation

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

- 9. Estimated cost of works..... \$35,000.00 with pumping facilities
- 10. Estimated time required to construct works..... 90 days
- 11. Estimated time required to complete the application to beneficial use..... 5 years

Waters are to be comingled with other rights of the Applicant.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 6.0 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
