hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

6. Place of use North half of the NW 1/4 of Section 14, the NE 1/4 of Section 14, the East 1/2

of the SE 1/4 of Section 14, the West 1/2 of the SW 1/4 of Section 13, the SE 1/4 of the

SW 1/4 of Section 13, the NW 1/4 of Section 24, and the SE 1/4 of the NE 1/4 of Section 23.

all within T2S, R67E, M.D.B. & M., Lincoln County, Nevada.

7. Use will begin about Jan 1-st and end about Dec 31-st of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and

specifications of your diversion or storage works.) Well, Pump, Casing, and sprinkler

system.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.34 cubic feet per second but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before May 10, 1977
- Proof of commencement of work shall be filed before June 10, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before May 10, 1978
- Proof of completion of work shall be filed before June 10, 1978
- Application of water to beneficial use shall be made on or before May 10, 1981
- Proof of the application of water to beneficial use shall be filed on or before June 10, 1981
- Map in support of proof of beneficial use shall be filed on or before June 10, 1981
