

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Alton C. Bingham, Suite 510, 1701 W. Charleston, of Las Vegas, Nevada 89102, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground source

2. The amount of water applied for is 4.8 cfs second-foot

(a) If stored in reservoir give number of acre-feet

3. The water to be used for irrigation and domestic purposes

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 280 acres

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: within the NE 1/4 NW 1/4 of Section 19,

T. 13S., R. 66E., M.D.B.&M., or at a point from which the Northeast corner of Section 19 bears North 87°00'00" East a distance of 2720 feet.

6. Place of use NE 1/4 NW 1/4; NW 1/4 NE 1/4; SE 1/4 NE 1/4; SW 1/4 NE 1/4; NW 1/4 SE 1/4; NE 1/4 SE 1/4 and the SE 1/4 SE 1/4

all in Section 19, T. 13S., R. 66E., M.D.B.&M., Clark County, Nevada.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump and approximately 2000 lineal feet of "V" irrigation ditch to connect to existing irrigation ditches in Section 19, T. 13S., R. 66E., M.D.B. &M.

- 9. Estimated cost of works..... Two Thousand Dollars (\$2,000.00)
- 10. Estimated time required to construct works..... Two years
- 11. Estimated time required to complete the application to beneficial use..... Five years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This application will supplement two existing wells on the Proposed Place of Use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

No perforations shall be put in the casing until after the well is completed and the log available for study. Perforations shall not start less than 100 feet from the surface unless the log shows a satisfactory confining formation nearer the surface.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.7 cubic feet per second but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before June 3, 1977
- Proof of commencement of work shall be filed before July 3, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before June 3, 1978
- Proof of completion of work shall be filed before July 3, 1978
- Application of water to beneficial use shall be made on or before June 3, 1981
- Proof of the application of water to beneficial use shall be filed on or before July 3, 1981
- Map in support of proof of beneficial use shall be filed on or before July 3, 1981
