This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the manner of use of the waters of Mud Spring #1 as heretofore granted under Permit 9044, Certificate 2287 is issued subject to the terms and conditions imposed in said Permit 9044, Certificate 2287 and with the understanding that no other rights on the source will be affected by the change proposed herein. A measuring device must be installed and measurements of water use kept.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed .0016 cubic feet per second but not to exceed 0.365 million gallons annually.

- Proof of commencement of work shall be filed before..... December 5, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before..... November 5, 1978
