This permit to change the manner of use of the waters of Rock Spring as heretofore granted under Permit 11459, Certificate 2979 is issued subject to the terms and conditions imposed in said Permit 11459, Certificate 2979 and with the understanding that no other rights on the source will be affected by the change proposed herein. A measuring device must be installed and measurements of water use kept.
