This permit to change the point of diversion of Blue Spring No. 1 as heretofore granted under Permit 22235, Certificate 6947 is issued subject to the terms and conditions imposed in said Permit 22235, Certificate 6947 and with the understanding that no other rights on the source will be affected by the change proposed herein. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed.....0.0093.....cubic feet per second...or sufficient water to water 300 head of cattle and 200 sheep.
