hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) The Quarter Circle J. P. Ranch

is owned exclusively by Mary S. G. Anderson and James S. W. Greil, except 5 acres reserved to Emily W. W. Greil.

- 1. The source of the proposed appropriation is Underground
2. The amount of water applied for is 2.0 second-feet
3. The water to be used for Irrigation and Domestic
4. If use is for: (a) Irrigation (state number of acres to be irrigated) 160 acres
5. The water is to be diverted from its source at the following point: in the SE 1/4 SE 1/4 Section 17...
6. Place of use E 1/2 E 1/2 Section 17...
7. Use will begin about January 1st and end about December 31st...
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) It is planned to drill, develop and equip an irrigation well which will be utilized with a sprinkling system to irrigate the E 1/2 E 1/2 of Section 17.

- 9. Estimated cost of works \$15,000.00
- 10. Estimated time required to construct works 1½ years
- 11. Estimated time required to complete the application to beneficial use 3 years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

..... This underground water will be used to supplement existing rights.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before December 8, 1978
- Proof of commencement of work shall be filed before January 8, 1979
- Work must be prosecuted with reasonable diligence and be completed on or before December 8, 1979
- Proof of completion of work shall be filed before January 8, 1980
- Application of water to beneficial use shall be made on or before December 8, 1982
- Proof of the application of water to beneficial use shall be filed on or before January 8, 1983
- Map in support of proof of beneficial use shall be filed on or before January 8, 1983
