6. Place of use SE 1/4 SE 1/4 Section 1, E 1/2 E 1/2 Section 12, T.13N., R.25E.; and portions of SW 1/4 SW 1/4 Section 6, and W 1/2 W 1/2 Section 7, T.13N., R.26E., M.D.B.&M.

7. Use will begin about January 1st and end about December 31st, of each year. Day and Month Day and Month
