The applicant S. G. Worsham and Loreen M. Worsham 1085 Maplewood Drive, of Reno, Nevada 89501, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground (Well) Name of stream, lake or other source.

2. The amount of water applied for is Five second-feet One second-foot equals 448.83 gals. per min.

6. Place of use Portions of the NW 1/4 SE 1/4, SW 1/4 SE 1/4, SE 1/4 SE 1/4, SW 1/4 SW 1/4, SW 1/4 NE 1/4, SE 1/4 NE 1/4, NE 1/4 NE 1/4 of Section 9, T.11N., R.25E., M.D.B.&M., and portions of NW 1/4 NW 1/4, SW 1/4 NW 1/4, NW 1/4 SW 1/4, and SW 1/4 SW 1/4 of Section 10, T.11N., R.25E., M.D.B.&M.

7. Use will begin about Jan. 1 and end about Dec. 31, of each year. Day and Month Day and Month

Surface Ditches and Moveable Irrigation Pipe, 14" well and submersible electric pump State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

- 11. Estimated time required to complete the application to beneficial use 2 years


