hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground (well) Name of stream, lake or other source.

2. The amount of water applied for is 2.7 second-feet One second-foot equals 448.83 gals. per min.

3. The water to be used for Irrigation and Domestic Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 160

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: within the SW 1/4 SE 1/4 of Section 5, T.12N., R.21E., M.D.B.&M., from which the southeast corner of said Section 5 bears S 85° 32' E, 1,474.2 feet.

6. Place of use SE 1/4 SW 1/4, SW 1/4 SE 1/4, SE 1/4 SE 1/4, all in Sec. 5; and the NE 1/4 NE 1/4 of Sec. 8; all in T.12N., R.21E., M.D.B.&M.

7. Use will begin about Jan. 1 and end about Dec. 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump, surface ditches and moveable irrigation pipes.
