

7. Use will begin about Jan. 1 and end about Dec. 31, of each year.

*This application is denied on the grounds that the granting of water rights for additional groundwater development from the designated Bedell Flat basin would conflict with existing rights and threaten to prove detrimental to the public welfare in this area where appropriations exceed estimates of perennial yield.*
