89449, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground

2. The amount of water applied for is 0.5 cfs second-feet

5. The water is to be diverted from its source at the following point: SW 1/4 SE 1/4 of Section 33, T.14N., R.20E., MDB&M, or at a point from which the S 1/4 corner of said Section 33 bears S. 64° 16' W. a distance of 1393.45 feet.

6. Place of use 1.5 acres in the SW 1/4 SE 1/4 and 0.5 acres in the SE 1/4 SE 1/4, Section 33, T.14N., R.20E., MDB&M. As shown on the supporting map.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump, motor and irrigation system.

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.
