Nev. 89410, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground Name of stream, lake or other source.

2. The amount of water applied for is 1.0 cfs second-feet One second-foot equals 448.83 gals. per min.

R. 20E. MDB&M bears S 1° 33' 40"E a distance of 6607.45 feet it should be stated.
