This application is herewith denied on the grounds that this appropriation of underground water for the irrigation of additional lands would tend to impair the value of existing rights and would be detrimental to the public interest and welfare within the Walker Lake Valley, Whiskey Flat - Hawthorne subarea. The irrigation of additional lands within the Walker Lake Valley, Whiskey Flat - Hawthorne subarea under these conditions is not considered to be a preferred use of the limited resource as provided under NRS Chapter 534.


