6. Place of use W 1/2 SE 1/4 of Section 31, T. 10N., R. 57E., MDB&M, Lots 2 & 3 of Section 6, T. 9N., R. 57E., MDB&M.

7. Use will begin about 1st of January and end about 31st of December of each year.
