This is to certify that I have examined the foregoing application, and do hereby deny the same, subject to the following limitations and conditions:

This application is denied on the grounds that the granting of underground water rights to irrigate additional land within the designated Fernley Area would conflict with existing rights and threaten to prove detrimental to the public welfare in this area where appropriations exceed estimates of recharge to the ground water reservoir.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed cubic feet per second
