

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant State of Nevada, Department of Fish and Game, Box 10678, of Reno, Nevada 89520, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground. Name of stream, lake or other source.

2. The amount of water applied for is 4.0 second-feet. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Fish, Wildlife and Recreation. Irrigation, power, mining, manufacturing, domestic, or other use.

- 4. If use is for: (a) Irrigation (state number of acres to be irrigated), (b) Stockwater (state number and kinds of animals to be watered), (c) Other use (describe fully under "No. 12. Remarks"), (d) Power: (1) Horsepower developed, (2) Point of return of water to stream.

5. The water is to be diverted from its source at the following point: in the NE 1/4 NW 1/4 of Section 30, T. 19N., R. 20E., MDB&M, from which the N 1/2 corner of Section 30 bears N. 39° 02' 00" E., 1547.50 feet.

6. Place of use. The S 1/2 NE 1/4 NW 1/4, the N 1/2 SE 1/4 NW 1/4, the NW 1/4 NE 1/4 and the NW 1/4 NE 1/4 NE 1/4 all in Section 30, T. 19N., R. 20E., MDB&M.

7. Use will begin about 1 Jan. and end about 31 Dec., of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) 14" well, cased, with sanitary seal and gravel filter pack; turbine pump.

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.
