The applicant Chris R. Winters 10109 OAKleaf RD, of Cupertino California 95014, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground wells

2. The amount of water applied for is 3 second-feet

7. Use will begin about 1 January and end about 31 December of each year.
