6. The existing point of diversion is located within the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 19 T.21N., R.19E., M.D.B.&M., at a point from which the W $\frac{1}{2}$ corner of said Section 19 bears S. 52⁰ 18' W., a distance of 1894.0 feet.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 28571 is issued subject to the terms and conditions imposed in said Permit 28571 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined annual duty of water under this permit and permits 34219 and 34221 shall not exceed 732.92 acre-feet. This permit is further issued subject to the terms and conditions of that certain agreement dated April 21, 1978 between the State Engineer and Leareno Development, Inc.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, but not to exceed 142.99 acre-feet annually.

- Work must be prosecuted with reasonable diligence and be completed on or before..... November 11, 1978
- Proof of completion of work shall be filed before..... December 11, 1978

- Proof of the application of water to beneficial use shall be filed on or before..... June 11, 1983
- Map in support of proof of beneficial use shall be filed on or before..... June 11, 1983
