waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Incorporated January 2, 1975

1. The source of the proposed appropriation is Underground Well No. 10

5. The water is to be diverted from its source at the following point: SE¼ SW¼ Section 1, T.34N., R.23E., M.D.B.&M., or at a point from which the Southwest corner of Section 1 bears S. 70° 05' W. 1625.00 feet

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drill well to approximately 6000 feet, install casing and cement back to surface to protect fresh water zones.

Hot water or steam will flow through pipeline to electric plant.

This application is for a geothermal well with a productions of 2.1 million gallons per day. The withdrawal will be 2352 acre feet per year; however, the high temperature water would be flashed with the net effect of 210,000 gallons per day being beneficially used and the remaining water returned to the reservoir so only 235 acre feet per year is actually used. This application is comingled with other applications. The total hot water-steam equivalent necessary for beneficial use is 3300 acre feet from all applications.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A measuring device must be installed and measurements of water use kept. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water granted herein at any and all times.

There are to be no perforations in the well for at least the first 5000 feet. The well is to be cemented from the 5000 foot level to the surface to protect fresh water zones. The total water - steam equivalent to be consumptively withdrawn from the geothermal ground water reservoir under Permits 34427 through 34443 is limited to 3300 acre-feet of water per year.

This permit is further issued subject to the condition that the power or energy generated by the beneficial use of this water or steam is subject to recapture and use within the boundaries of the State of Nevada when the need arises.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.25 cubic feet per second, but not to exceed 235.0 acre-feet annually.

- Actual construction work shall begin on or before November 3, 1978
- Proof of commencement of work shall be filed before December 3, 1978
- Work must be prosecuted with reasonable diligence and be completed on or before November 3, 1979
- Proof of completion of work shall be filed before December 3, 1979
- Application of water to beneficial use shall be made on or before November 3, 1984
- Proof of the application of water to beneficial use shall be filed on or before December 3, 1984
- Map in support of proof of beneficial use shall be filed on or before December 3, 1984
