The existing point of diversion is located within SW 1/4 SW 1/4 Section 29, T. 39 N., R. 37 E., M.D.B. & M., or at a point from which the NW corner Section 30, T. 39 N., R. 37 E., M.D.B. & M., bears North 52° 55' West a distance of 6,801 feet. If point of diversion is not changed, do not answer.

7. Proposed place of use Section 29, T. 38 N., R. 37 E., M.D.B. & M. (640 acres) Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 30064 is issued subject to the terms and conditions imposed in said Permit 30064 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total diversion of water under this permit and any and all permits issued on Section 19, T.38N, R.37E, M.D.B.&M. shall not exceed 10.8, c.f.s.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.7 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before October 26, 1978
- Proof of commencement of work shall be filed before November 26, 1978
- Work must be prosecuted with reasonable diligence and be completed on or before March 5, 1979
- Proof of completion of work shall be filed before April 5, 1979
- Application of water to beneficial use shall be made on or before March 5, 1979
- Proof of the application of water to beneficial use shall be filed on or before April 5, 1979
- Map in support of proof of beneficial use shall be filed on or before April 5, 1979
