APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner of use, place of use of the waters of an underground source as heretofore granted under Permit 29378 is issued subject to the terms and conditions imposed in said Permit 29378 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

There are to be no perforations in the well for at least the first 1500 feet. The well is to be cemented from the 1500 foot level to the surface to protect fresh water zones.

This permit is further issued subject to the condition that the power or energy generated by the beneficial use of this water or steam is subject to recapture and use within the boundaries of the State of Nevada when the need arises.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not

to exceed.....5.0.....cubic feet per second, but not to exceed.....

3620 acre-feet annually.

Actual construction work shall begin on or before.....May 9, 1979.....
