EXHIBIT "B"

This application changes the Place of Use of a portion of the waters owned by the Applicant pursuant to Permit No. 27234, Certificate No. 8793. The same well, pump, motor and distribution system is to be utilized as is presently used.

The Place of Use described in this Application to change the Place of Use of a portion of the above mentioned certificated right is within the same 40-acre subdivisions as described on the certificated right, but will consist of approximately 500 additional homes. Thus, this Application to Change the Place of Use of a portion was filed rather than an Application to Appropriate the Public Waters.

The State Engineer has issued applicant seven Certificates of Appropriation totalling 364.06 million gallons per annum that serve a community water system composed of 1168 units. It is to be expressly understood that applicant does not intend to utilize more than the 364.06 million gallons per annum, but rather intends to serve additional homes from water saved by various water conservation methods. The exact number of additional homes will be determined as water saving methods are implemented. It is estimated that approximately 500 additional units will be added to the system.

The water pursuant to this Application is to be comingled with the six other wells owned by Valley Water Company. Use map on file under Permit No. 30088.
