

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Nevada State Public Works Board 505 E. King Street, of Carson City Nevada 89701, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground Name of stream, lake or other source.

2. The amount of water applied for is 2.5 second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for irrigation and domestic Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated) 80 acres

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power: (1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: in the SE 1/4 of the NE 1/4 of section 25, T17N, R19E, MDB&M, from which the East 1/2 corner of said section 25 bears S 04° 56' E 557 feet

6. Place of use E 1/2 of NE 1/4, Section 25, T17N, R19E, MDB&M

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well, pipes & ditches

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

- 9. Estimated cost of works..... \$15,000
- 10. Estimated time required to construct works..... 18 months
- 11. Estimated time required to complete the application to beneficial use..... 3 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is further issued subject to the terms and conditions of the State Engineer's ruling dated September 20, 1978.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2 cubic feet per second, but not to exceed 0.730 million gallons annually.

Actual construction work shall begin on or before April 11, 1979

Proof of commencement of work shall be filed before May 11, 1979

Work must be prosecuted with reasonable diligence and be completed on or before April 11, 1980

Proof of completion of work shall be filed before May 11, 1980

Application of water to beneficial use shall be made on or before April 11, 1982

Proof of the application of water to beneficial use shall be filed on or before May 11, 1982

Map in support of proof of beneficial use shall be filed on or before

Commencement of work filed DEC 1 8 1978

Completion of work filed MAY 2 3 1980

Proof of beneficial use filed JUN 1 1 1985


