The applicant Security Housing Corporation and Steven G. and Vicki L. Wickman 401 South Highland Drive, of Las Vegas, Nevada 89106, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Incorporated in Las Vegas, Nevada in 1964.

1. The source of the proposed appropriation is underground, Clark County

2. The amount of water applied for is 0.0037 second-feet

The water is to be diverted from its source at the following point: in the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of Section 15, Township 22 South, Range 60 East, M.D.M., Clark County, Nevada, from which the Southeast Corner of said Section 15 bears South 60°11'18" East, 933.3 feet.

6. Place of use NE 1/4 SW 1/4 SE 1/4 SE 1/4 of Section 15, Township 22 South, Range 60 East, M.D.M., Clark County, Nevada

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) water to be diverted by a 8" cased well and distributed by pipe lines.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed in the discharge pipeline, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0037 cubic feet per second, but not to exceed 0.73 million gallons annually.
