herby make \$ application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Corporation - April 17, 1978; Wilmington, Delaware.

1. The source of the proposed appropriation is underground

2. The amount of water applied for is three (in combination with water supply well no. 2) second-foot One second-foot equals 448.83 gals. per min.

3. The water to be used for mining, milling and domestic

5. The water is to be diverted from its source at the following point: in the SE 1/4, SW 1/4 of section 25, T22N, R57E, MDB&M, or a point from which the SW corner (found) of section 36, T23N, R57E, bears N 4° 24' W, 25,820 feet.

6. Place of use sections 22 through 27 and 34 through 36, T22N, R57E, MDB&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well with pump and motor, pipeline to storage tanks, and thence to use points.

- 9. Estimated cost of works.....\$50,000.....

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water granted herein at any and all times.

The total combined duty of water under this permit and Permit 35965 shall not exceed 708.0 million gallons annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second, but not to exceed 708.0 million gallons annually.

- Actual construction work shall begin on or before January 11, 1980
- Proof of commencement of work shall be filed before February 11, 1980
- Work must be prosecuted with reasonable diligence and be completed on or before January 11, 1981
- Proof of completion of work shall be filed before February 11, 1981
- Application of water to beneficial use shall be made on or before January 11, 1984
- Proof of the application of water to beneficial use shall be filed on or before February 11, 1984
