This is to certify that I have examined the foregoing application, and do hereby ~~grant~~ the same, subject to the following limitations and conditions:

.....This application is hereby denied on the grounds that the land proposed to be irrigated is presently covered with water rights for the irrigation of said land under existing Permit 21839, Certificate No. 6733, and the granting of Application 36382 would constitute an additional diversion of water from this concentrated area which would adversely affect existing rights and be detrimental to the public welfare.
