Point of Diversion and Place of Use of a portion

of water heretofore appropriated under Permit 23710, Certificate 6375

1. The source of water is Underground Source, Well 2 Name of stream, lake, underground, spring or other source.

2. The amount of water to be changed 1.32 cfs or 99 acre feet Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for Irrigation and Domestic Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore used for Irrigation and Domestic Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point SW 1/4 NW 1/4 Section 24, T3S, R54E, M.D.B.&M., or at a point from which the Southwest corner of said Section 24 bears, S 07° 50' Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be 02" W a distance of 2948.15 feet stated.

6. The existing point of diversion is located within SW 1/4 NE 1/4 Section 24, T3S, R54E, M.D.B.&M., or at a point from which the West 1/4 corner of said Section 24 bears, S 89° 03' W If point of diversion is not changed, do not answer. a distance of 2680.0 feet

7. Proposed place of use 20 Acres in the NW 1/4 Section 24, T3S, R54E, M.D.B.&M. Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.

8. Existing place of use 20 Acres in the SW 1/4 NE 1/4 Section 24, T3S, R54E, M.D.B.&M. Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.

9. Use will be from January 1 to December 31 of each year. Month and Day Month and Day

10. Use has been from January 1 to December 31 of each year. Month and Day Month and Day

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 23710, Certificate 6375 is issued subject to the terms and conditions imposed in said Permit 23710, Certificate 6375 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 36441, 36442 and 36443 shall not exceed 511.21 acre-feet annually for the irrigation of 125 acres.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not

to exceed 1.32 cubic feet per second, but not to exceed 99 acre-feet annually.

Actual construction work shall begin on or before N/A

Proof of commencement of work shall be filed before N/A

Work must be prosecuted with reasonable diligence and be completed on or before November 31, 1990.

Proof of completion of work shall be filed before December 31, 1990.

Application of water to beneficial use shall be made on or before November 31, 1991.

Proof of the application of water to beneficial use shall be filed on or before December 31, 1991.

Map in support of proof of beneficial use shall be filed on or before December 31, 1991.
