This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

..... This permit is issued subject to all existing rights on the source. It is
 understood that the amount of water herein granted is only a temporary allowance and
 that the final water right obtained under this permit will be dependent upon the
 period of use and the average number of livestock served from the waters of this
 source. The State retains the right to regulate the use of the water herein granted
 at any and all times but does not take responsibility for the use of the Federal
 range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.012 cubic feet per second, or sufficient water to water 500 head of cattle.
