515 South Fifth Street, of Elko, Nevada 89801, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground Well
Name of stream, lake or other source.

2. The amount of water applied for is 5.4 cfs second-feet
One second-foot equals 448.83 gals. per min.

3. The water to be used for Irrigation
Irrigation, power, mining, manufacturing, domestic, or other use.

6. Place of use N 1/2 NE 1/4 Section 7, SE 1/4 NE 1/4 Section 7, NW 1/4 Section 8, NW 1/4 SW 1/4 Section 8, all in T33N, R53E, MDB&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well, Pump, Pipeline, Ditches and Sprinkler System.

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

11. Estimated time required to complete the application to beneficial use 5 years
