- 1. The source of the proposed appropriation is underground
2. The amount of water applied for is 5.4 second-feet
3. The water to be used for irrigation
4. If use is for: (a) Irrigation (state number of acres to be irrigated) 300 acres

5. The water is to be diverted from its source at the following point: NE 1/4, SE 1/4, Sec 23, T13S, R63E BDB&M or at a point from which the S 1/4 corner said sec 23, bears S 45° 00' 00" W, 3,500 ft.

6. Place of use SE 1/4 SW 1/4 and SW 1/4 NE 1/4 SW 1/4 and W 1/2 SW 1/4 and SW 1/4 NW 1/4 and SW 1/4 NW 1/4 NW 1/4 Sec 24 T13S R63E MDBM and N 1/2 NW 1/4 NW 1/4 sec 25 and E 1/2 SE 1/4 and E 1/2 NW 1/4 SE 1/4 Sec 23

7. Use will begin about 1 Jan and end about 31 Dec, of each year.
