6. Place of use SW 1/4, SE 1/4 NW 1/4, Lot 2, Section 18, T. 17N., R. 64E., S 1/2 NE 1/4 Section 13, T. 17N., R. 63E., MDB&M.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drill and case irrigation well, install motor driven deep well pump, 8 and 10" irrigation pipe lines and wheeled sprinkler system
