- 1. The source of the proposed appropriation is an underground source
2. The amount of water applied for is 7.4 cfs
3. The water to be used for irrigation and domestic purposes
4. If use is for: (a) Irrigation (state number of acres to be irrigated) 320 acres

5. The water is to be diverted from its source at the following point: within the SW1/4 NW1/4 of Section 10, T.16S., R.55E., M.D.B. & M., Clark County, Nevada or at a point from which the SW corner of said Section 10 bears South 23°40'00" West a distance of 3050 feet
6. Place of use SW1/4; the NW1/4 SE1/4; the SW1/4 NE1/4 and the S1/2 NW1/4 of Section 10, T.16S., R.55E., M.D.B. & M., Clark County, Nevada

7. Use will begin about January 1st and end about December 31st, of each year.
