

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Gordon C. Shelley

Nevada 89503, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Underground Well #2
2. The amount of water applied for is 0.25 cubic feet per second
(a) If stored in reservoir give number of acre-feet
3. The water to be used for Domestic and commercial
4. If use is for:
(a) Irrigation (state number of acres to be irrigated)
(b) Stockwater (state number and kinds of animals to be watered)
(c) Other use (describe fully under "No. 12. Remarks") zoned A-1 with trailer overlay
(d) Power:
(1) Horsepower developed
(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: within the SW 1/4 of the SW 1/4 of Section 8, Township 20N., Range 19E., MDB&M, from which point the SW corner of said Section 8 bears South 4° 44' West a distance of 825.0 feet.

6. Place of use portions of the SW 1/4 of the SW 1/4 and portions of the NW 1/4 of the SW 1/4 of said Section 8, Township 20N., Range 19E, MDB&M, Washoe County, Nevada as is shown on the map which supports this application.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well and storage tank

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

9. Estimated cost of works..... Excess of \$25,000.00

10. Estimated time required to construct works..... 1 year

11. Estimated time required to complete the application to beneficial use..... 3 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

(a) This well is merely the deepening of an existing well, which in turn was drilled in the center of an artesian spring (vested) in use on the property prior to 1906. (b) This well is in conjunction with another application of the same date. This is a back up well, and in no case will both wells ever use over 100 gals per minute, in the aggregate total. (c) The place of use is zoned for mobile homes, Units A-1 with trailer overlay.
