Washington 99336, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground

2. The amount of water applied for is 5.4 cfs second-feet
One second-foot equals 448.83 gals. per min.
