

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Reed Ranching Co., Inc. c/o Boyack Surveying, Inc. 515 South Fifth Street, of Elko, Nevada 89801, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) January 1978, in Elko, Nevada

1. The source of the proposed appropriation is Cedar Well. Name of stream, lake or other source.

2. The amount of water applied for is 0.5 cfs second-feet. One second-foot equals 448.83 gals. per min.

3. The water to be used for Stockwater Irrigation, power, mining, manufacturing, domestic, or other use.

The water is to be diverted from its source at the following point: SW 1/4 SW 1/4 Section 10, T30N-R55E, MDB&M, at a point from which the SE corner of section 36, T30N-R55E, MDB&M bears S35° 04' 58" E, 26,119.04 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use SW 1/4 SW 1/4 Section 10, T30N - R55E, MDB&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Day and Month Day and Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed ..... 0.0312 ..... cubic feet per second, or sufficient water to water ..... 1000 head of cattle .....
