The applicant Robert J. Beaumont, dba, Big Springs Ranch
Chilton Engineering 421 Court, of Elko, Nevada 89801, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Reynolds Well
Name of stream, lake or other source.

2. The amount of water applied for is 0.05 cfs second-feet
One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet. acre-feet

3. The water to be used for Stockwater & Domestic
Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:
(a) Irrigation (state number of acres to be irrigated)

(b) Stockwater (state number and kinds of animals to be watered) 1000 head cattle, 100 head horses

(c) Other use (describe fully under "No. 12. Remarks")

5. The water is to be diverted from its source at the following point: w/in NW1/4 SW1/4 Section 26, T.38N., R.66E., M.D.M., or at a point from which the SW corner of said Section 26 bears S. 24°00' W., 2704 feet.

6. Place of use NW1/4 SW1/4 Section 26, T.38N., R.66E., M.D.M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled and cased well equipped with gasoline motor and Jensen Jack with watering troughs.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source.  
It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.  
This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.  
The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0343 cubic feet per second, or sufficient water to water 1000 head of cattle and 100 horses.

Actual construction work shall begin on or before N/A

Proof of commencement of work shall be filed before N/A

Work must be prosecuted with reasonable diligence and be completed on or before December 23, 1983

Proof of completion of work shall be filed before January 23, 1984

Application of water to beneficial use shall be made on or before December 23, 1985

Proof of the application of water to beneficial use shall be filed on or before January 23, 1986
