hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

April 28, 1947-Nevada

1. The source of the proposed appropriation is Hilt Springs #1 Name of stream, lake or other source.

2. The amount of water applied for is 0.10 second-feet One second-foot equals 448.83 gals. per min.

3. The water to be used for Stockwatering Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

The water is to be diverted from its source at the following point: Within the SW 1/4 SE 1/4 of Section 18, T.43N., R.65E., M.D.M. or at a point from which the SW corner of Section 31 T.43N., R.65E., bears S 90 25' W, 16600 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use The SW 1/4 SE 1/4 and SE 1/4 SW 1/4 of Section 18 T.43N., R.65E., M.D.M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Improve and clean spring site with ditch systems.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.012 cubic feet per second or sufficient to water 400 head of cattle.
