The applicant SIERRA PACIFIC POWER COMPANY

Nevada 89510, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

March 31, 1965

1. The source of the proposed appropriation is Underground Name of stream, lake or other source.

2. The amount of water applied for is 1.5 c.f.s., second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Industrial Use-Cooling water for steam electric generating plant Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated)

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: Situate in the SW 1/4 of Section 25,

T2N, R59E, MDM Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use Section 24, T2N, R59E, MDM Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Water will be developed by means of a drilled well and thence conveyed by pipeline to the steam electric generating plant State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits. where it will be used as condenser cooling water.

- 9. Estimated cost of works.....\$200,000.00.....
- 10. Estimated time required to construct works..... 1 year.....
- 11. Estimated time required to complete the application to beneficial use..... 5 years.....
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

A 1500 megawatt generating plant will be served by this well in conjunction with several other wells in the area. The generating plant will use approximately 6,000 acre feet of water per year.
