APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Zimmerman Ranching Corporation, of Round Mountain, Nevada 89045, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) 1972 Nevada

1. The source of the proposed appropriation is Wall Canyon Well. Name of stream, lake or other source.

2. The amount of water applied for is 0.05 cfs second-feet. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet. acre-feet

3. The water to be used for stockwatering. Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated). (b) Stockwater (state number and kinds of animals to be watered) 200 head of cattle. (c) Other use (describe fully under "No. 12. Remarks"). (d) Power: (1) Horsepower developed. (2) Point of return of water to stream.

5. The water is to be diverted from its source at the following point: in the SW 1/4 SE 1/4 of Section 5, T. 9N., R. 43E., MDB&M, or at a point from which the Southeast corner of said Section 5 bears S 68° 31' E 1,820'. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use SW 1/4 SE 1/4 of Section 5, T. 9N., R. 43E., MDB&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) 8" cased well, pump, stockwatering trough. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0062 cubic feet per second, or sufficient water to water 200 head of cattle.

- Actual construction work shall begin on or before June 22, 1981
- Proof of commencement of work shall be filed before July 22, 1981
- Work must be prosecuted with reasonable diligence and be completed on or before June 22, 1982
- Proof of completion of work shall be filed before July 22, 1982
- Application of water to beneficial use shall be made on or before June 22, 1983
- Proof of the application of water to beneficial use shall be filed on or before July 22, 1983
- Map in support of proof of beneficial use shall be filed on or before.....
