hereby make s application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) 1972 Nevada

1. The source of the proposed appropriation is unnamed spring Name of stream, lake or other source.

2. The amount of water applied for is .01 c.f.s. second-feet One second-foot equals 448.83 gals. per min.
