This application is for a geothermal well with a production of 2.1 million gallons per day. The withdrawal will be 3520 acre feet per year; however, the high temperature water would be flashed with the net effect of 210,000 gallons per day being beneficially used and the remaining water returned to the reservoir so only 352 acre feet per year is actually used. This application is commingled with other applications.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. If the well is flowing, a valve must be installed and maintained to prevent waste. Accurate measurements must be kept of water placed to beneficial use. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

There are to be no perforations in the well for at least the first 1,500 feet. The well is to be cemented from the production levels to the surface to protect fresh water zones.

This permit is further issued subject to the condition that the power or energy generated by the beneficial use of this water or steam is subject to recapture and use within the boundaries of the State of Nevada when the need arises.

This permit is further issued subject to the condition that only geothermal fluids are to be diverted and used beneficially for heating purposes only and fresh, cold water aquifers are not to be diverted.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 3.25..... cubic feet per second., but not to exceed a consumptive use of 352 acre-feet annually.
