The applicant 7-K Ranching Corporation
Route 2, Box 13, of Round Mountain, Nevada 89045, hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) 1978 Nevada

1. The source of the proposed appropriation is Hot Springs
