The applicant **Joseph B. Key c/o Boyack Surveying, Inc.**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground**
2. The amount of water applied for is **8.0 cfs** second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Irrigation and Domestic**
4. If use is for:

5. The water is to be diverted from its source at the following point **NE¹/₄ SW¹/₄ Section 2, T33N, R57E, MDB&M., from which the NW Corner of said Section 2 bears N 21°51'27" W 4108.27 feet.**
6. Place of Use **E¹/₂ E¹/₂ Section 4, All of Section 3, All of Section 2, NE¹/₄ Section 10 T33N, R57E, and S¹/₂ S¹/₂ Section 35, N¹/₂ SW¹/₄ Section 35, NW¹/₄ SE¹/₄ Section 35, T34N, R57E, MDB&M.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Well, Ditches, Pipelines and Sprinkler System.**
9. Estimated cost of works **\$50,000**
10. Estimated time required to construct works **3 years**
11. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

This permit is limited to the irrigation of 160 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, and not to exceed a yearly duty of 3.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

January 12, 2001

Proof of completion of work shall be filed before:

February 12, 2001

Water must be placed to beneficial use on or before:

January 12, 2001

Proof of the application of water to beneficial use shall be filed on or before:

February 12, 2001

Map in support of proof of beneficial use shall be filed on or before:


