This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0016625 cubic feet per second, or sufficient water to water 50 head of cattle.

Actual construction work shall begin on or before July 19, 1981

Proof of commencement of work shall be filed before August 19, 1981

Work must be prosecuted with reasonable diligence and be completed on or before July 19, 1982

Proof of completion of work shall be filed before August 19, 1982

Application of water to beneficial use shall be made on or before July 19, 1983

Proof of the application of water to beneficial use shall be filed on or before August 19, 1983
