(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Nevada 1972

Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use S 1/2 SE 1/4 Sec. 12, NE 1/4 Sec. 13 all in T.12N., R.42E. MDB&M Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day

Applications 42433, 42657, 42658, 42659, 42660, 42661, 42663, 42667, 42669, 42671, 42672, 46767, 46768, 46770, 46771, 46773, 46774 and 46775 are herewith denied and any further extensions of time to complete the diversion works and place the water to beneficial use on permits 42663, 42667, 42671 and 42672 are herewith denied on the grounds that to grant applications or maintain permits for irrigation purposes on lands that the applicant does not own or control and cannot demonstrate the ability to place the water to beneficial use, would not be in the public interest and welfare.
