hereby make application for permission to change the Point of Diversion

of water heretofore appropriated under Permit #30997

1. The source of water is Underground

2. The amount of water to be changed 2.0 c.f.s.

3. The water to be used for Irrigation and Domestic

6. The existing point of diversion is located within the SE1/4 SE1/4 Section 17, T.16N., R.20E., M.D.B.&M., or at a point from which the Southeast corner of said Section 17 bears South 55°37'04" East, a distance of 1507.41 feet

7. Proposed place of use E1/2 E1/2 Section 17, T.16N., R.20E., M.D.B.&M. (160 Acres)

8. Existing place of use not changed

9. Use will be from January 1 to December 31 of each year.

10. Use has been from January 1 to December 31 of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump and motor to serve a proposed sprinkler system

- 12. Estimated cost of works \$5,000.00

 APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 30997 is issued subject to the terms and conditions imposed in said Permit 30997 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined amount of water granted under this permit and Permit 31286 is limited to what the well covered under the two permits is capable of producing. If certificates of appropriation are issued under this permit and Permit 31286, the total combined amount of appropriation granted in said certificates shall not exceed what the well covered under the two permits is capable of producing.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before July 22, 1981
- Proof of commencement of work shall be filed before August 22, 1981
- Work must be prosecuted with reasonable diligence and be completed on or before July 22, 1981
- Proof of completion of work shall be filed before August 22, 1981
- Application of water to beneficial use shall be made on or before December 8, 1982
- Proof of the application of water to beneficial use shall be filed on or before January 8, 1983
- Map in support of proof of beneficial use shall be filed on or before January 8, 1983
