This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 30937 is issued subject to the terms and conditions imposed in said Permit 30937 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is issued with the understanding that 41.14 acres in lot 3, and 10.00 acres within the E½ E½ SE¼ NW¼ of Section 4, T.12N., R.43E., M.D.B.&M., are not included in the place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 6.0..... cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
