California 95355, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is underground
2. The amount of water applied for is 5.4 c.f.s.
3. The water to be used for irrigation and domestic
4. If use is for:
(a) Irrigation (state number of acres to be irrigated) 320 acres
(b) Stockwater
(c) Other use
(d) Power:
(1) Horsepower developed
(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: SW 1/4 of NE 1/4 of Section 25, T.18N., R.45E., M.D.B.&M. or at a point from which the SE corner of said Section 25 bears South 18°58'00" East, 4074 feet.
6. Place of use NW 1/4 of NE 1/4; NE 1/4 of NE 1/4; SW 1/4 of NE 1/4; SE 1/4 of NE 1/4; NW 1/4 of SE 1/4; NE 1/4 of SE 1/4; SW 1/4 of SE 1/4; SE 1/4 of SE 1/4; all in Section 25, T.18N.-R.45E.-M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, cased, turbine pump and sprinkler system.

- 9. Estimated cost of works..... \$80,000
- 10. Estimated time required to construct works..... 3 years
If well completed, describe works.
- 11. Estimated time required to complete the application to beneficial use..... 4 years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.
